Dear Ms. Wojnaroski,

By way of introduction, Nevada Homeschool Network (NHN) advocates for Nevada families who have chosen to direct the education of their children pursuant to NRS 392.070. We are writing today in response to a request from Indiana Association of Home Educators (IAHE) regarding testimony given about Nevada homeschooling and the NV public schools during a meeting of the US Commission on Civil Rights Indiana Advisory Committee on February 17, 2016.

Contrary to testimony given by Ms. Leslie Hiner (page 98-99) **Nevada public schools do not automatically refer parents of troubled students to a "homeschool expert" in our state.** This is a misrepresentation of an example of one relationship that is currently working in NV... A homeschool mom and volunteer NHN advocate, turned educational options advocate, gets calls from parents who are looking into homeschooling. These calls are referred out by one school district's "homeschool office"; an office which is not meant for homeschoolers, but merely exists to process Notice of Intents required by law. These students are not always troubled, and homeschooling is not always the right option for the family.

While Nevada homeschoolers enjoy a good relationship with the NV Department of Education we do not have any kind of agreement with the DOE nor the school districts to counsel parents of troubled (expelled) students. However, Nevada Homeschool Network (NHN) is listed on the [NV-DOE website](#) as a "resource" for parents considering home-schooling. Additionally, school districts will refer parents to NHN (a statewide organization) or other homeschool support groups in the local community if parents have questions about homeschooling.

To clarify Nevada statutes regarding homeschooling; private school enrollment and homeschooling are "exemption" options to NRS 392.040 that compels children between the ages of 7 and 18 to be enrolled in a Nevada public school (or charter school). NV parents who **choose** to homeschool under NRS 392.070 and 392.700 **"take full responsibility for the education of the child"** by filing a minimal Notification of Intent to Homeschool and are subject to educational neglect laws, the same as all NV parents. In 2007, The Homeschool Freedom Bill unanimously passed both houses of the Nevada Legislature and was signed into law by the Governor of Nevada. As a result, **homeschooling in Nevada is no longer regulated by the State Board of Education/DOE.** Therefore, a Nevada public school may not "transfer a student to homeschooling". **Further, it is not NHN's mission to "discourage" parents from homeschooling but rather to educate them about the responsibility of homeschooling and advocate for their right to do so.** If parents choose to homeschool, we assist them in getting started on the excellent educational option that homeschooling can afford their student. If parents choose not to homeschool, we inform them of other options available to them under Nevada law.

Lastly, as part of NHN's objective, in 2005 we worked with our state legislature to ensure that these "troubled" youth had expanded options, NOT just homeschooling. We forged paths with charter schools and won the right for expelled students to enroll in these schools as well as expanding options within the public school system through either independent study or distance education, should they be the right fit for the family. Applicable statutes are available upon request. **Homeschooling is an education option that is appropriate for many families and the right to homeschool a liberty issue that NHN has advocated for since 2002.**
